

GENERAL CONDITIONS OF SALES

Section 1 - General provisions

These ACE Education Spain General Conditions of Sale (hereinafter referred to as the GCS) are intended to establish the conditions under which ACE Education Spain offers the following product: the summer program. This program provides the opportunity to have practical and theoretical skills in sports business (AMOS), luxury hotel management (CMH), or in the field of fashion and luxury (EIDM). This program combines academic lectures, hands-on workshops, and cultural immersion. The educational content, including lectures, practical workshops, and other events, as well as accommodation conditions and locations, may be adjusted from the initial offering to better align with the needs and trends of these sectors. However, in the event of any changes, ACE Education Spain guarantees an equivalent level of quality and service as originally offered.

These ACE Education Spain General Conditions of Sale automatically applied to any order and constitute the agreement that will govern the relations between ACE EDUCATION SPAIN, registered trademark of the company AIDEA DEVELOP S.L.U CIF B-98.540.792 (hereinafter, "ACE Education"), and any natural or legal person, whether natural or professional and under private or public law (hereinafter, "the student"), wishing to participate in one or more courses offered by ACE Education and/or have signed the registration form designating the private law contract signed between ACE Education and the client as part of the sale of services, for the entire duration of the contract.

Section 2 – Jurisdiction

If any dispute or difference cannot be settled amicably, the Spanish courts shall have exclusive jurisdiction. The student, aware that the training is carried out from Spain and, expressly waiving any other jurisdiction that may correspond to them, submits to the Courts and Tribunals of the City of Valencia for any controversy that may arise from the relationship between the student and the center.

Section 3 – Conditions of access

Access to the summer programs is based on an application file. An admission interview may also be arranged depending on the participant's profile, allowing him to detail their motivation for joining the program. Participants are required to obtain a tourist visa and must independently complete all administrative formalities necessary for their participation in the program.

Additionally, insurance is mandatory for the entire duration of the summer program. This insurance must cover at least medical expenses, repatriation, and baggage loss. A copy of the insurance policy must be sent to the campus no later than **15 days** before the start of the program. Failure to provide proof of insurance will result in the student's exclusion from the program, without the possibility of a refund for any fees paid.

Section 4 - Terms of Registration and Financial Participation

Registrations for the Summer Programs offered by ACE Education Spain are open until May 31, 2025. After this date, no further registrations will be accepted.

According to the payment schedule established at the time of registration, the participant agrees to pay the full program fees according to the payment schedule established at the time of enrollment. If the student does not follow the payment schedule and fails to pay the required amounts, he will not be able to participate in the program. The student will remain entitled to pay for the full payment, and no refunds will be made.

Section 5 - Enrollment cancellation conditions

Any signed enrollment agreement is considered firm and final following the withdrawal period of 14 calendar days as of the day following the agreement's signature. The student will then be liable to pay the cost of the course for the entire cycle.

Withdrawal before the start of the program:

Withdrawal means that the student has chosen to withdraw before the start of the course. Fees will remain due to the school according to the following conditions:

- For any cancellation request before February 28, 2025: full refund
- For any cancellation request between March 1, 2025, and May 31, 2025: 50% refund of the course cost
- For any cancellation request from June 1, 2025: no refund

*(% of the total amount of the program price).

Drop-out after the start of the program:

Drop-out means that the student has chosen to withdraw after the start of the course. The students remain liable to ACE Education Spain for the full course cost related to their enrollment.

Cancellation of the programs by ACE Education Spain.

The continuation of a summer program depends on a minimum of 8 enrolled students. If ACE Education Spain cancels the program, all fees will be refunded in full within a maximum of 90 days from the date of the cancellation notice.

Compelling reasons and force majeure

In the event of withdrawal due to a compelling, legitimate, and verified reason, the student will be fully reimbursed for the fees paid. The following reasons are considered compelling, legitimate by ACE Education Spain:

- a natural disaster;
- a health pandemic;
- serious accident or illness of the participant
- justified visa denial by relevant authorities
- official travel restrictions or border closures

Postponement of Program Participation

It is not possible for a student to defer his participation in the program, regardless of the reason for the deferral request.

Definitive exclusion from a course:

The school may sanction any student breach of the obligations imposed by the internal rules and regulations (disciplinary reasons, lack of work or attendance, etc.) with definitive exclusion from the course. In this case, the excluded student will be liable for all course costs.

Section 6 - Internal rules and regulations

Any enrollment in a summer program implies the student's respect for the internal rules and regulations of ACE Education Spain as well as those of its partners, which are attached to this enrollment agreement. If these rules are not attached, they will be provided to the participant no later than the first day of the program. It is important to note that the internal regulations are liable to be modified, and the student therefore implicitly undertakes to respect any modifications that may arise.

Section 7 - Personal data protection

In compliance with the Organic Law on the Protection of Personal Data, regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016, you are informed that your data will be incorporated into a file owned by AIDEA DEVELOP SLU with CIF B98540792 and whose purposes are: the treatment of these, to carry out the admission study and keep you informed of the conclusions and evolutions of this and the subsequent educational relationship student school. As student, you are also informed that you can exercise the rights of access, rectification, deletion, portability, limitation of treatment, cancellation and, where appropriate, opposition, by sending a written request accompanied by a photocopy of your ID to the following address: Avenida Catalunya, 6, Valencia, as well as claim before the Spanish Agency for Data Protection (www.agpd.es) when the interested party considers that AIDEA DEVELOP SLU has violated the rights that are recognized by the applicable regulations on data protection.
